Limitation of the holder's functions of the Honorary Consulate in Hobart (Australia)



Decrees:

Mr. Antonio Gerardo De Cesare, Honorary Consul in Hobart (Tasmania, Australia), in addition to fulfilling the general duties of defending national interests and protecting citizens, exercises consular functions limited to:

a) receipt and physical transmission to the Consulate General of Italy in Melbourne of civil status documents received from local authorities, Italian citizens or commanders of national or foreign ships or aircraft;



b) receipt and physical transmission to the Consulate General of Italy in Melbourne of declarations concerning civil status by ship and aircraft commanders, or by witnesses;

c) receipt and physical transmission to the Consulate General of Italy in Melbourne of wills drawn up on board ships and aircraft by Italian citizens; d) receipt and physical transmission to the

Consulate General of Italy in Melbourne of documents dependent on the opening of succession of Italian citizens or to which they may be called Italian citizens;

e) issuing of protective deeds, which do not imply the disposition of the assets of Italian citizens, in matters of succession, shipwreck or air accident, with the obligation to promptly inform the Consulate General of Italy in Melbourne;

f) urgent initial investigation activities in the event of maritime or air accidents or injuries on board ships, pleasure boats or national aircraft, after having first consulted the Consulate General of Italy in Melbourne on a case-by-case basis;

g) receipt and transmission to the Consulate General of Italy in Melbourne of applications for registration in the registry and electoral lists in Italy submitted by citizens who are resident in the territorial district of the Honorary Consular Office;

h) receiving and transmitting driving licence renewal applications to the Consulate General of Italy in Melbourne and delivering the renewal certificate to the applicant;

i) receipt and material transmission to the Consulate General of Italy in Melbourne, competent for any decision on the matter, of documents relating to pensions;

j) delivery of certificates issued by the Consulate General of Italy in Melbourne; k)

certification of life for pension purposes; l) receipt and transmission of requests for authentications and legalizations; m) receipt and transmission of requests for

authentication of signatures on private documents, deeds of notoriety, and the issuance of special powers of attorney concerning natural persons to Italian citizens, in the cases provided for by law;

n) receipt and physical transmission to the Consulate General of Italy in Melbourne of documentation relating to the issuance of passports to citizens residing in the territorial jurisdiction of the Honorary Consular Office; direct delivery of receipts of delivery to the holders of passports issued by the Consulate General of Italy in Melbourne;

o) capturing the biometric data of compatriots requesting an electronic document, for subsequent forwarding to the first category consular office;

p) receiving and transmitting to the Consulate General of Italy in Melbourne the documentation relating to requests for the issuance of the Emergency Travel Document (ETD) submitted by Italian citizens and citizens of EU member states, after having received the report of theft or loss of the passport or other travel document and after having carried out the appropriate checks, pursuant to Article 71 of Presidential Decree No. 445 of 28 December 2000, on the veracity of the self-certifications referred to in Articles 46 and 47 of the aforementioned Presidential Decree; delivery of the ETDs, issued by the Consulate General of Italy in Melbourne, valid for a single trip to the Member State of which the applicant is a citizen, to the country of permanent residence, or, exceptionally, to another destination; q) receipt and transmission to the Consulate General of Italy in Melbourne of the documentation relating to requests for the issuance of identity cards - presented by Italian citizens residing in the jurisdiction of the Honorary Consular Office

after having carried out the appropriate checks, provided for pursuant to art. 71 of the Decree of the President of the Republic of 28 December 2000, n. 445, on the veracity of the

self-certifications pursuant to Articles 46 and 47 of the aforementioned Presidential Decree; direct delivery to the holders of identity cards issued by the Consulate General of Italy in Melbourne and physical return of the cards signed by the latter to the Category I Consulate;

r) receiving and transmitting to the Consulate General of Italy in Melbourne the documentation relating to entry visa requests;

s) assistance to compatriots in need or in temporary difficulty and carrying out the preparatory activities for the purpose of granting subsidies or loans with the promise of repayment to the treasury by the Consulate General of Italy in Melbourne;

t) carrying out collateral duties, without prejudice to the powers of the Consulate General of Italy in Melbourne, relating to the preparation and updating of conscription lists, as well as the processing of applications for the regularization of the conscription status of draft evaders, with the aim of administratively deleting the evasion note from the general list of draft evaders. The powers of conscription are excluded;

u) carrying out the operations required by current legislation in relation to the arrival and departure of a national vessel, as well as keeping the relevant registers;

v) receipt and transmission to the Consulate General of Italy in Melbourne of documentation relating to requests for the release, renewal or validation of ship or maritime personnel safety certifications (endorsements); delivery of the aforementioned certifications, issued by the Consulate General of Italy in Melbourne;

w) notification of documents to Italian citizens residing in the jurisdiction of the Honorary Office, communicating the outcome of the same to the competent Italian Authority and, for information, to the Consulate General of Italy in Melbourne;

x) collaboration in updating the register of resident Italian nationals by the Consulate General of Italy in Melbourne;

y) maintenance of the signature register of local authorities.

This decree is published in the *Official Journal of the Italian Republic*.
